Instructions for Use of Certification Certificates and Certification Marks

1. Certification

1. The use of certification certificates

The certification certificate issued by Lyard Standard Technical Services (Jiangsu) Co., Ltd. proves that your organization's management meets the management system standards on which the certification is based. The certificate has the GAIA certification logo, and the certificate can only be used for your unit's bidding, bidding, advertising and product catalog, and the certificate shall not be lent or diverted for other purposes;

2. Maintain the certification certificate

The certificate is valid for three years from the date of issuance, and a new certificate needs to be renewed upon expiration. During the validity period of the certificate, it is necessary to accept the supervision and audit of our company every year, and the annual confirmation notice is issued to meet the requirements, and the certification certificate is valid for use at the same time as the annual confirmation notice of the current year.

Recertification is required at the end of the three-year period, and a new certification certificate will be issued if the certification requirements are met.

3. Renewal of certification certificate

In addition to the need to renew the certificate, when the following changes occur, please also apply for your unit, our company will renew the certificate of your unit, and the renewal of the certificate will be carried out in combination with the annual supervision and audit;

- --Expand or narrow the scope of certification;
- --Changes or changes in the standards on which the certification is based;
 - -- The name and address of your organization have changed, etc.

Second, the certification mark

1. After your unit obtains the certification of our company, you can conditionally use the certification mark (certification mark + enterprise registration number), and you need to formulate a plan for use before using it, and submit it to our company for review and filing.

- 2. Our company will provide you with a vector diagram of the logo, and your unit needs to use it in the form specified in the agreement.
- 3. Your unit can use the management system certification logo for bidding, bidding documents, advertising and product catalogs, not for products and product packaging.
- 4. In the use of the certification mark, it shall not be interpreted in any way to indicate the conformity of the product.

The specifications and specifications of the GAIA logo are shown in Figure 1 and can be enlarged or reduced proportionally and must be legible.

3. Accreditation mark

1. After your unit obtains the certification certificate within the scope of our company's recognition, you can conditionally use the IAF-MLA/IAS international mutual recognition joint logo: before use, you need to formulate a use plan and submit it to our company for review and filing.

- 2. Our company will provide you with a vector diagram of the logo, and your unit needs to use it in the form specified in the agreement.
- 3. Your unit can use the management system certification logo for bidding, bidding documents, advertising and product catalogs, not for products and product packaging.
- 4. In the use of the approval mark, it is not allowed to take any way to interpret the conformity of the product.

4. Revocation of certification qualifications

If your organization seriously violates the requirements of the specification for the use of certification certificates or the management system, and cannot continue to meet the relevant

requirements, the relevant certification will be revoked according to the relevant requirements. Our customer service staff will send you a notice of revocation of certification, asking you to stop using the certification certificate and logo and send the certificate back within the specified time. Our company will revoke the list of certified customers, publicize it on the company's website, and report it to the CNCA for publicity.

If you continue to use the certification certificate and related marks after our company makes the decision to revoke the certification qualification, the consequences and related legal responsibilities shall be fully borne by your company, and our company reserves the right to prosecute by law.

5. Suspension of certification qualifications

If your organization violates the requirements of the certification certificate or management system, and cannot continue to meet the relevant requirements, the relevant certification qualification will be suspended according to the relevant requirements. Our company's customer service staff will send a notice of suspension of certification to your unit, requiring you to stop all certification advertising during the suspension period, and stop using the certification certificate and certification mark, and the

promotional materials that have been printed with the certification mark should also be immediately stopped, and the relevant suspension information will be publicized on the company's website, and reported to the CNCA for publicity.
